## **No.1 Source:**

Our family's Culture & Environment which is controlled and influenced by parents is the No.1 Source, when we raised up our kids to habituated with certain cultural habits like Eating & Drinking, Manners, Characteristics, Talking habits, Life Style, Iman and Aqeeda which the children inherited from their childhood & bring it with them when they grew up & at time of marriage, they bring the same Habitual cultural influence to their in laws house, which influence broadly both families but when there are big differences it creates lots of conflicts in the marriage where both of families took themselves their enemies since they seems always against of Natural expressions(of bride/ groom) & day to day work, it could be a complaint or insult or irritation developed by both families since ultimately it effects the couple & their love life & intimacy, caused huge conflict, fight, relationship turmoil, doubt in relationship spark huge conflict & disputes and ended up with divorce. Where sometimes due to lack of Iman and lack of knowledge about Islam keep the both parents away from the couple and they left the matter to the couple those who are most inexperienced to deal with marital matter, and we as a parents always feel shy to discuss about any privacy matter and concerned about child so this leave a big gap and they step out for help from some person who are also ineligible and caused more distress into their marriage life, they often commits Kufr like went to Peer baba, maulana, friends, Astrologer to solve their problem where those people can't solve their matter even worsening it ,not even the mother from both child unable to fix the issues since they both



has bitter and negative experiences in their own life and they saw everything from that angle and become emotional and advised such decision those are very harmful and reach to a position that divorce can't be undone.

We often also gave the task of mediation to solve the marriage problem in some person's hand those who has lack of knowledge of Sunnah of Rasool SAW(PBUH) and they are blind and harmful for the whole community and sometimes they are partial and selfish and blind, all the direction or judgement they gave there is an end result i.e. divorce. We can look from this Sahih Hadith below that how our beloved Prophet SAW(PBUH) used to be an integral part of the private life of his SAW(PBUH) daughter Fatima Ra. And Son in Law Ali Ra.

We tried to stand up (as a mark of respect) but Allah's Messenger (ﷺ) said: Keep to your beds, and he sat amongst us and I felt the coldness of his feet upon my chest. He then said: May I not direct you to something better than what you have asked for? When you go to your bed, you should

It is reported on the authority of Ali that Fatima had corns in her hand because of working at the hand-mill. There had fallen to the lot of Allah's Apostle (ﷺ) some prisoners of war. She (Fatima) came to the Prophet (ﷺ) but she did not find him (in the house). She met A'isha and informed her (about her hardship). When Allah's Apostle (ﷺ) came, she (A'isha) informed him about the visit of Fatima. Allah's Messenger (ﷺ) came to them (Fatima and her family). They had gone to their beds. 'Ali further (reported):



recite Takbir (Allah-o-Akbar) thirty-four times and Tasbih (Subhan Allah) thirty-three times and Tahmid (al-Hamdu li-Allah) thirty-three times, and that is better than the servant for you.

Life, often he SAW(PBUH) used to discuss and solve any matter related marital bliss and solve personal conflicts, and Prophet SAW(PBUH) also never biased to his SAW(PBUH), and he SAW(PBUH) always encourage to Fatima Ra. To adjust to any hardship or hard work inside the home, on the other hand he SAW(PBUH) reacted to matter from the angel of a father (PBUH) that when Ali Ra. Decided to marry the daughter of Abu Jahl. And a father should react in such cases we must refer from this example from the life of Rasool SAW(PBUH)

'Ali b. Husain reported that Miswar b. Makhramah informed him that 'Ali b. Abi Talib sent the proposal of marriage to the daughter of Abu Jahl as he had Fatima, the daughter of Allah's Messenger (ﷺ), (as his wife). When Fatima heard about it, she came to Allah's Apostle (ﷺ) and said:

The people say that you never feel angry on account of your daughters and now 'Ali is going to marry the daughter of Abu Jahl. Makhramah said: Thereupon Allah's Messenger (ﷺ) rose up and I heard him reciting Tashahhud and say: Now to the point. I gave a daughter of mine (Zainab) to Abu'l-'As b. Rabi, and he spoke to me and spoke the truth. Verily Fatima, the daughter of Muhammad, is a part of me and I do not approve that she may be put to any trial and by Allah, the daughter of Allah's Messenger cannot be combined with the daughter of God's enemy (as the co-wives) of one person. Thereupon 'Ali gave up (the idea of his intended) marriage.
